## A PROCLAMATION

WHEREAS Section 1D of The Community Improvement Act, 1968 (17 Eliz. II, Cap. 11) enacts as follows: "1D (1) The Lieutenent-Governor in Council

- 1D (1) The Lieutenant-Governor-in-Council may, where the residents of a proposed community have recommended the establishment of a committee and have recommended the geographical boundaries of the community, establish a committee and fix the geographical boundaries of the community.
  - (2) The Lieutenant-Governor-in-Council shall establish a committee and fix the geographical boundaries of a community by proclamation.
  - (3) The Minister may appoint not less than six persons recommended by the residents at the meeting held pursuant to Section 1B to act as members until the first annual meeting held by the committee, and such persons shall hold office until the first annual meeting is held by the committee."

AND WHEREAS the residents of the community of New Haven and Riverdale have recommended the establishment of a community improvement committee of New Haven - Riverdale and have recommended geographical boundaries of the community;

AND BEING SATISFIED that all of the provisions of The Community Improvement Act, 1968 have been complied with;

NOW KNOW YE that We, by and with the advice and consent of Our Executive Council for Prince Edward Island do by this Our Proclamation establish a community improvement committee to be known as "the Community Improvement Committee of New Haven - Riverdale" and fix the geographical boundaries of the said community as follows:

ALL THAT AREA of land contained within the former school district of Riverdale and the former school district of New Haven, excluding that area known as Dunedin which has been incorporated as part of "the Community Improvement Committee of Clyde River."

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and the Great

Seal of Prince Edward Island to be hereunto affixed.

WITNESS the Honourable George J. Tweedy, Administrator of the Government of the Province of Prince Edward Island, at Charlottetown this third day of October in the year of Our Lord one thousand nine hundred and seventy-four and in the twenty-third year of Our Reign.

## NOTICE UNDER THE QUIETING OF TITLES ACT

TAKE NOTICE that Nicholas DeJong and Susan DeJong, both of Loyalist Road in Queens County in the Province of Prince Edward Island, claim to be the absolute owners to fee simple of the lands hereinafter described.
