# Mayors Report

- → Mayor thanked the EMO Chair, staff, and volunteers for running the RMWR's warming centers.
- → Mayor was helping at the warming center and attending the daily beefing meeting of EOC at Afton CC.
- → Mayor attended Emergency Measure, Finance, Planning, and Properties Committee meetings.
- → Mayor received a letter from Minister Fox, a response to Mayor's September 8, 2002, and after reviewing the timeline of SPA amendment and communication with RMWR:
  - March 30, 2022 Executive Council (EC2022-210) approved amendments to several sections of the Planning Act Subdivision and Development Regulations, including changes to Section 63 Special Planning Area Regulations.
  - o April 9, 2022 EC2022-210 SPA amendments came into force.
  - May 9, 2022 EC2022-210 has come to the attention of the Planning Board (PLB16.7), as
    a portion of our Municipality is within the SPA, and therefore, we are directly impacted
    by amendments to these regulations. In addition, given that the Municipality is
    presently engaged in the process of developing a new OP and LUB, changes to Section

- 63 of the SPA regulations also impact that project. RMWR was not consulted prior to these changes being made, and the CAO has confirmed that the PEI Federation of Municipalities were also not consulted prior to these changes taking effect nor informed after the date they came into force. Planning Board requests that Council consider sending a letter to the Minister of Fisheries & Communities and the Minister of Agriculture & Land and copy the PEIFM too.
- May 12, 2022 As RMWR is presently engaged in the process of developing a new OP & LUB, EC2022-222 directly impacted this project. Also, RMWR was not consulted before these changes were made, and the Council was informed that the PEI Federation of Municipalities were not consulted prior to these changes taking effect nor informed after the date they came into force. The Council of RMWR unanimously passed a motion and approved the PLB request that the Mayor Send a letter to the Minister of Fisheries & Communities and the Minister of Agriculture & Land and copy the PEIFM.
- May 31, 2022 The Minister and Deputy Minister of the Department of Fisheries & Communities Director of Municipal Affairs met with RMWR's Mayor, Deputy Mayor, Chair of the Planning Board and CAO. RMWR expressed concerns regarding section (63)
   Special Planning Area Regulations amendment.
- June 1, 2022 Executive Council (EC2022-451) approved amendments to Subsection 63(5) of the Planning Act Subdivision and Development Regulations (EC693/00) is amended.
- June 9, 2022 Mayor wrote a letter to Ministers Thompson and Fox asking:
- The RMWR has very much appreciated the ongoing advice and support we have received from your departments during the amalgamation process, and it was an unpleasant surprise to learn that the regulation amendments were in place without any prior consultation taking place. We have confirmed that the PEI Federation of Municipalities was also not consulted prior to these changes taking effect. While we don't speak on behalf of the PEIFM, as a member municipality, the lack of communication seems contrary to the positive relationships all parties have worked hard to build and maintain over the course of the implementation of the new Municipal Government Act. The RMWR respectfully asks for your departments to respond to the following questions:

- 1. What prompted the recent amendments to the Regulations?
- 2. What consultation work and review were undertaken to consider these amendments?
- 3. Why were the impacted municipalities within the Special Planning Area, who are obligated to ensure compliance, not consulted?
- June 20, 2022 Municipal Affairs informed RMWR that they would respond to the Mayor's June 9, 2022 letter, and the department believes the impact of these changes on municipalities to be minimal.
- July 11, 2022 Planning Board requests that Council consider sending a letter to the Minister of Fisheries & Communities and the Minister of Agriculture & Land and CC the PEIFM following up on the lack of communication (PLB18, As RMWR was informed neither in the meeting of May 31 nor in the email of June 20 regarding the upcoming changes to SPA (PLB18.5).
- July 14, 2022 Following PLB18.5's recommendation, The Council of RMWR
  unanimously passed a motion and approved the PLB request that the Mayor Send a
  letter to the Minister of Fisheries & Communities and the Minister of Agriculture & Land
  and copy both MLAs and the PEIFM.
- July 29, 2022 The Deputy Minister of Agriculture and Land responded to the Mayor's
  June 9, 2022, letter mentioning the SPA amendments as housekeeping and minor
  corrections, which these changes may directly impact some municipalities. Following
  WRC#28 Mayor would send the second letter as some unanswered questions remained.
- September 8, 2022 Mayor sent Minister Fox and Minister Compton a letter regarding the SPA (Special Planning Areas) mentioning:
  - SPA amendments were once again made without notice or consultation with impacted municipalities or the PEI Federation of Municipalities is concerning.
     Even more so, perhaps, since Department of Fisheries and Communities officials communicated with our Municipality during that interim period and made no mention of the second amendments that were forthcoming. It, unfortunately, reinforces the perception that the Province does not place enough importance

- on transparent communication and therefore, we felt compelled to send this second letter.
- 2. The November 2021 changes to Sections 2 and 2.1 of the Planning Act signal the Province's intention to encourage the integration of plans at the provincial and municipal levels to address the significant climate, social, and environmental challenges our Province is facing. The Rural Municipality of West River welcomes the opportunity to partner with your departments, and we respectfully ask that more consideration and attention be given to our role in these planning matters and the relevant legislation that guides us all.
- October 3, 2022 Minister Fox responded to the Mayor's September 8, 2022 letter pointing out:
  - We have raised your concerns with the Department of Agriculture and Land with respect to a lack of consultation regarding recent changes to the Planning Act Subdivision and Development Regulations.
  - We agree that transparency and communication are vitally important to provide effective land use planning, both within and outside of municipal planning authority.
  - 3. The government is currently embarking on initiatives to foster increased interdepartmental collaboration on important issues such as these. We are hopeful that increased transparency and communication will result and assist in alleviating concerns like these in the future.
- → The Council approved the Mayor to send a letter to the Minister of Fisheries & Communities as there is neither a clear explanation to the asked question nor a suggestion of any corrective actions in the received response of October 3, 2022, and copy the Minister of Agriculture & Land, both MLAs and the PEIFM. It was moved by Councillor Sharon Slauenwhite and seconded by Councillor Stephen Gould.
