WHEREAS

Municipal staff have proposed opening an after-school care program at the Afton Community Centre, and

WHEREAS

This resolution bears the recommendation of the Committee of Council as discussed at a meeting held on May 8th, 2025

BE IT RESOLVED

The Council for the Rural Municipality of West River approves the opening of a Municipally run afterschool childcare program at the Afton Community Centre for the 2025-26 School Year subject to enrolment of at least 20 children and authorizes the CAO to execute it.

The Council for the Rural Municipality of West River approves the proposed budget (attached hereto forming a part of this resolution) and authorizes that any costs not recouped through the program fees will be paid for out of the new Rural Municipality Grant for the 2025-26 Fiscal Year.
